#### Global Trade ESG Specialist Level 1

The aim of *Global Trade ESG Specialist Level 1* is to build your foundational knowledge related to ESG global trade regulations. This course reviews the key environmental, social or governance frameworks and/or entry barriers that impact your supply chain and import/export programs.

ESG-centric regulations are rapidly increasing as countries and regions implement stricter environmental, social, and governance standards to combat climate change and forced labor while promoting sustainable practices. Over 2,000 climate-related non-tariff barriers, such as carbon taxes, environmental labelling, sustainability certifications, and sustainability reporting are already in effect globally. These regulations can significantly impact:

- 1. your operations by raising the complexity of your compliance programs and changing manufacturing and logistics processes
- 2. your market access by requiring the adoption of sustainable processes in your supply networks and value chains
- 3. your competitiveness by forcing innovation and transparency for customers and investors
